# About Nancy Galkowski

Nancy Galkowski served as a local government administrator for 35 years in Massachusetts' towns and was an officer in the International City Management Association (ICMA), a Board member of the Massachusetts Municipal Association (MMA) and a former president of Massachusetts Municipal Management Association (MMMA). She was deeply committed to lifelong learning and professional development opportunities not only for professionals just starting their careers in municipal management, but also for existing and long-time managers whose budgets may preclude them from pursuing such opportunities.

## Mission of the Legacy Fund

Please note that requests for tuition for college level degree courses are not eligible and will not be considered, including any certificate programs, such as those offered at Suffolk University, UMass-Boston, Clark University and beyond. We will not be considering any applications for the Suffolk University Certificate in Local Government Leadership & Management Program.

Please note that membership in the MMMA is not a prerequisite to applying.

## **Application Criteria**

Applications are to be completed electronically and will be evaluated based on the following criteria:

- 1. Compatibility of request with mission of the Legacy Fund and Nancy's passion for the profession
- 2. Applicability/relevance of program request to applicant's current /future position in the profession
- 3. Financial need of applicant
- 4. Plan to share program materials
- 5. Applicability/relevance of program to others in the organization, i.e. potential for program to benefit others within the organization
- 6. Potential for training the trainer
- 7. Commitment to becoming a member of the MMMA, if not already a member
