





Town of Norfolk's Temporary Emergency Shelter Managing Misinformation in a Small Town

On Friday, May 10, the Town found out the decommissioned Bay State Correctional Center had been designated as a temporary emergency shelter by the Healey Administration.

 - 50% Concern and/or outrage
 - $^\circ~$ 50% Let's wait to see impact. What can we do to help?
- Press requests
 - Local, Statewide, National, Global
 - Washington Post, Swedish Documentary
- Voicemail inboxes full
 - A few were valid questions/concerns regarding the situation
 - Some were offers of assistance and volunteers
 - A lot were explicit, hateful comments about staff, Select Board members, the migrants, political figures, MA Governor etc.
 - $^{\circ}$ The rest were a result of being in national headlines

- PR Firm for press releases

- Suburban town located in Norfolk County, approximately 30 minutes southwest of Boston
- Population: 11,594
- Select Board (3 members) Town Meeting Town Administrator
- MBTA station, rural feel
- 2 Elementary Schools (close to capacity) & King Phillip Regional School – High and Middle
- A lot of staff **Presidents**

Communication Strategy: One message from centralized source, then rely on help

• Two Channels:

- Town Facebook page only for pushing out info, no comments
- Town Website News posts and e-notify alerts

• Set up a Shelter Dashboard on the website

- Centralized location for any all information regarding the shelter
 - If not on dashboard, it's not official
 - Worked w/schools = one message

• Help from trusted and informed community partners

- ^o Town staff who are residents, other board members
- Civic and community groups
 - Share Town message online
 - correct misinformation in real time
 - Helped Town Admin and policy leader stay out of fray

The Town was informed on Friday. May 10th, that the decommissioned Bay State Correctional Center had been designated as a temporary emergency shelter by the Healey Administration. This decision was made as part of its ongoing response to the number of migrant families arriving in Massachusetts. The Town had no role in this decision and was not consulted prior.

al Response:

An unexpected influx of a large number of families poses many logistical challenges to Norfolk. Town Administrator Justin Casaroo-Denix Policis Cheff introm Heinz, Free Cheffer From Kinney, Norfolk School Superintedent Ingrid Allardi, King Philip Superintedent Rich Drotet, and other department backers will meet regularly in the coming days and weeks. This group, along with the Select Board, will develop a comprehensive ling to potential impacts to the Town and develop strategies to continue to definer regular municipal services without interrutors. We also will have regular conversations with Late officials to ensure the Town's concerns are heard, and to work collaboratively on creative solutions that are in the best interrests of Norfolk.

The Public Forum





- In theory, great idea but this event inflamed the situation for the Town and increased lack of trust from residents
- Anger towards the State because of their lack of information
- Scheduled during a time where the State did not know a lot of facts or were not able to communicate them
- Emotions were raised and questions/comments sometimes came from valid concerns and fear regarding the economic/political landscape

Norfolk's Community Facebook Page

• A friend and foe for misinformation

- Not run by the Town, but has responsible page admins
- Page admins would correct misinformation & shut down post if out of control
- $^{\circ}~$ it's hard to correct w/ such low public trust
- Several other Facebook pages developed from the community page posts – pro/con shelter
- Facebook post on July 12 Migrants are being given cars by the state
 - Rumor grew throughout the day and resulted in many calls to the Town, elected officials, and local press
 - "My taxes are paying for them to have cars" "I can't even afford a car"
 - Ended up putting out a press release to address the rumor

Are cars being provided to families at shelters?

Families at the Bay State Overflow Shelter and other shelters in the Commonwealth are not being provided with cars. While Heading Home is offering transportation services at Bay State, individual vehicles are not available to families. Our office has learned that some families at other sites, who have started working, have pooled their money to purchase a vehicle, but the State does not provide these vehicles.

• Public Safety and Schools

- Two biggest issues for the Town was the potential impact on schools and public safety
- Small Town with limited resources, not much commercial revenue, and two schools already at capacity. All valid concerns.
- Communication challenge: misinformation that hits people where it hurts the most – their kids and safety
 - $^{\circ}$ $\,$ None of those kids will be vaccinated in time for school $\,$
 - Once they are here they have the right to go to school here even if they move
 - $^{\circ}$ What will happen to my kids IEP?
 - If my allergic son gets stung by a bee and the Town's only available ambulance is responding to a call at the shelter, what

happens? My son dies?

Outside Groups





- With the attention from the national headlines, Norfolk attracted many "outsiders" who used fear and sensational misinformation to cause chaos
- Outside political groups (throughout New England) sent members to the public forum and local protests
 - Not directly impacted by this, planted to push own agenda
 - $^{\circ}~$ Were the loudest, heckled speakers and residents
- Easy to take advantage in a low trust environment

Lessons Learned

Centralized message

- Online dashboard
- $^{\circ}$ Collaboration with schools = one message

Utilized our community structure

 $^{\circ}$ Staff, local leaders, civic groups corrected misinformation

Reach out to your neighboring communities


• How did they handle communications?

Don't tell someone else's story

- $^{\circ}~$ The State had a story to tell, not the Town
- $^{\circ}$ Direct questions to the organization who owns the story

• Keep staff informed along the way

 $^{\circ}$ They will be your biggest advocates





Cambridge's Temporary Emergency Shelter • Hosted approximately

- 70-80 families
- Shelter was located at state-owned Registry of Deeds building
- Multiple rumors over the first month




Strategies to Control the Spread

- Steadfast Monitoring
- Act Quickly
- Set Thresholds
- Demonstrated Empathetic Transparency and Relentless Follow-Up
- Be Coordinated and Consistent
- Leverage Influencers and Local Leaders

Establish Educational Frameworks

- Launch Information literacy campaigns
- Promote hubs for digital literacy workshops
- Create awareness around detection tools



Actionable Steps for Leaders

- Establish a crisis communications plan
- Monitor key topics
- Build partnerships with fact-checkers
- Invest in public awareness
- Train employees and communications teams
- Establish policies so employees can engage and respond responsibly
