


Implementing Federal Match legislation (Chapter 214 of the Acts of 2024)



\$156 million award through Solar for All program

The Massachusetts Department of Energy Resources (DOER), the Massachusetts Clean Energy Center (MassCEC), MassHousing, and the Boston Housing Authority were awarded \$156,120,000 for clean energy investments to up to 31,000 low-income and affordable homes from the EPA's Greenhouse Gas Reduction Fund.



\$342 Million in Massachusetts Awards for Reconnecting Communities from USDOT

The U.S. Department of Transportation announced awards for the Reconnecting Communities and Neighborhood Grant Program. This includes \$335 million to replace the Allston Viaduct and create new and improved access to expanded waterfront parks and open space in Boston, as well awards for Haverhill, Lynn, Everett, Cambridge and Chelsea.



\$993 Million Award for the Cape Cod Bridges

\$993 million in funding from the USDOT's **Bridge Investment Program (BIP)** towards MassDOT's replacement of the Cape Cod Bridges. Adds to over \$700 million in existing federal funding for the project. Phase 1 of the project will begin with the replacement of the Sagamore Bridge.

\$77 million for Municipal Roadway Safety Improvements

Awards were made to municipalities across the state through the Safe Streets and Roads for All program. This funding will allow municipalities and regional planning agencies to implement strategies to reduce transportation-related fatalities and injuries.



\$24 million to rehabilitate and extend the Leonard's Wharf Project in the Port of New Bedford

This Port Infrastructure Development Program award will allow for its continued use as a commercial fishing pier, expand its capacity for use in staging offshore wind projects, and increase its climate resiliency by raising the wharf to account for sea level rise.



\$75 Million for Clean School Buses

Awards were made to
Massachusetts from the Environmental
Protection Agency's Clean School Bus
Program which will go towards replacing
fossil-fuel powered school buses in Boston,
Worcester, New Bedford, Fall River, and 17
other Massachusetts school districts.





\$35 million for cleaning up and rehabilitating former industrial sites

Awards from the EPA's Brownfields program will help assess, clean up, and rehabilitate former industrial sites in 13 communities. The cleanup of these sites will allow them to be repurposed into community assets in Gateway Cities and rural areas across Massachusetts.



\$147 Millions for Broadband

Massachusetts awarded over \$147,000,000 from the National Telecommunications and Information Agency's Broadband, Equity, Access, and Deployment program to expand high speed internet access in unserved and underserved locations in the state.



\$57 million for roadway improvements

Awards through USDOT's RAISE program were granted to Everett, Salem,
Gardner, New Bedford, Brockton,
and Lowell. Previous awards were
also made to New Bedford, Brockton, and
Lowell.

\$21 Million for Congestion Relief in Boston

MAPC, in partnership with Boston and MassDOT was awarded \$21,600,000 from the USDOT Congestion Relief Program. Funds will be used to bolster public transportation, expand blue bike availability, cohesive network access, and transit incentive research.







\$45 Million for Conservation in Massachusetts

Mass Audubon was awarded \$25,000,000 and EEA was awarded \$20,835,000 from the USDA Regional Conservation Partnership Program. Funds will be used to protect thousands of acres of land and boost climate resilience in Massachusetts

\$175 Million for Rail Improvements in MA

MassDOT was awarded \$36,800,000 from the DOT-FRA Consolidated Rail infrastructure & Safety Improvements program. Funds will be used to advance West-East Rail, building on the \$108,000,000 award from last year. 2 other Massachusetts entities were also awarded over \$30,000,000.



? Signed on September 24th, Bill S.2954 An Act to Provide for Competitiveness and Infrastructure Investment in Massachusetts

CHAPTER 214 OF THE ACTS OF 2024

The legislation unlocks up to \$750 million in resources to pursue federal funding opportunities. Including:

- MATCHING FUNDS AND LENDING: and/or other financial assistance to municipalities as they pursue federal funds.
- TECHNICAL ASSISTANCE: \$12 million towards local government technical assistance.

Adds to the over \$2 billion in existing resources Massachusetts has made available for state match to give Massachusetts a competitive edge in the pursuit of historic federal grant opportunities












IRA TAX CREDITS: DIRECT PAY



Direct Pay Clean Energy Tax Credits: The Basics

- By filing a newly created form of tax return and using Direct Pay, non-taxable entities can receive a cash refund from the IRS for certain clean energy projects.
- Direct pay applies to clean energy projects put into service January 1, 2023 through December 31, 2032, creating a future decade of tax-based cash refunds to reduce net capital cost of infrastructure replacements and upgrades.
- In most cases, the Investment Tax Credit results in a refund equal to 30% of the project investment but can escalate to 50% of the project investment.
- Direct Pay builds on existing clean energy tax credits that are well established and commonly used to fund projects in all 50 states.
- Unlike competitive grant programs, the potential dollar value of these tax credits to states and municipalities is unlimited.

Placement in non-urban or low income areas

Section 30C

Renewable electricity production tax credit (PTC)

EV Fleet Transition

- Gov. vehicles, school
 buses, public transit, etc.
- Stacking available with EPA funding

Section 45W

Qualified commercial vehicles

Section 48

Energy investment tax credit (ITC)

Example Projects:

- Microgrid/ Community Solar
- Storage deployed at distribution level
- Port electrification
- Rooftop Solar or Wind on gov. buildings or affordable housing
- Geothermal HVAC

Some Basics on Bonuses

Please Note: Additional details apply

Low-income Communities

10-20% bonus

... if project is in a low-income community with extra bonus if residential or econ benefit project

ITC only

Energy Communities

10% bonus

...if project is in historical "energy community" (i.e., closed coal mine, some brownfield sites)

Applies to both ITC tax basis and PTC rate

Prevailing Wage and Apprenticeship**

5x bonus

...if reqs for prevailing wages and registered apprentices are met

Applies to both ITC tax basis and PTC rate

Domestic Content* **

10% bonus

...if 100% of applicable steel and iron and an applicable share of 'manufactured products" produced in U.S.


Applies to both ITC tax basis and PTC rate

* - On December, 28, 2023, IRS issued new guidance on this rule for projects beginning in 2024 (see Notice 2024-9)

How Direct Pay Credits and Bonuses Affect a \$2M Project

Example:

- A municipality with brownfield status installs microgrid with solar and energy storage.
- Eligible for an ITC (Energy ITC, Sec. 48)
- Project cost is \$2M



What's Next? 2025 and Beyond

1. Identify projects in the pipeline with in-service dates of 2024 or later:

- Build an internal team by working with financial advisors and counsel to confirm eligibility, gather documentation, address key questions.
- Complete pre-registration for each project with 120 days prior to filing (advised)
- File Tax Forms generally 4.5 months after the end of the tax period.
 - May 15th for calendar year filers and November 15th for fiscal year filers.

2. Identify specific technical assistance needs and communicate to FFIO/OCIR:

- Tax filing assistance and legal questions?
- Project design and planning?
- Bridge loans?

3. Inventory capital needs (new construction, retrofits or vehicles) over the next decade:

- Include tax credit value into real estate and vehicle fleet planning.
- Ensure architects, designers, and facilities managers are aware of tax credit opportunities.

4. Make a plan for how your municipality will get its share of refunds over the next decade.
